Packed in raffia sacks, paper sacks with inner plastic foil, plastic bag, Aluminium complex film bag, plastic jars/carafe/bucket or big-bag. Production (blending and filtering) and packing of sweet and spicy Capsicum oleoresins in plastic jars. Packing Food colouring in jars and plastic bags. Production (mixing) and packing of vanilla sugar in paper sacks, plastic sacks, plastic bags, aluminium complex film bags and plastic jars. Including the outsourced process of smoking of dried Capsicum.
